

Privacy Notice

This Privacy Notice explains how and why [MR JOSEPH EDWARD] (“we”, “us”, or “our”) collects, uses, and shares personal information when you interact with or use this [Chromablind] (“App” or “Service”).

➤ Information collection

We may collect the following categories and types of personal information from and about you:

- 1) email address.
- 2) the type, version, brand, language and operating system of device.
- 3) the type and operator of network (such as Mac address).
- 4) device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- 5) behavioral usage of the App.

➤ Use of information

We use information we collect:

- 1) to develop, provide, and improve the Service.
- 2) to contact you with administrative communications and address your inquiries.
- 3) to enforce and comply with the law, including to conduct an investigation, to protect our property and rights, to prevent or stop activity we may consider to be, or to pose a risk of being, illegal, fraudulent, unethical or legally actionable activity.
- 4) to comply with our legal obligations.

➤ Information sharing

We may share information with:

- 1) Service providers and individuals we employ to facilitate our Service and to provide the Service on our behalf.

- 2) government agencies as required by law including (without limitation) in response to lawful requests by public authorities to meet national security or law enforcement requirements.
- 3) with our parent company and any current or future subsidiaries or affiliates, primarily for business and operational purposes.

➤ **Children**

The App is general audience and intended for users 13 and older. We do not knowingly collect personal information from anyone younger than age 13. If we become aware that a child younger than 13 has provided us with personal information, we will use commercially reasonable efforts to delete such information from our files. If you are the parent or legal guardian of a child younger than age 13 and believe that we have collected personal information from your child, please contact us

➤ **Information security**

We implement technical and organizational measures in order to maintain the security of the App, our services and personal information and in preventing unauthorized access, loss, misuse, alteration, destruction or damage to it through industry standard technologies and internal procedures.

➤ **Information retention**

Unless you request that we delete certain information, we will only retain your personal information for as long as is necessary to fulfill the purposes for which it was collected, including for the purposes of satisfying any legal, regulatory, accounting, or reporting requirements, as well as ongoing fraud prevention, backup, and business continuity purposes.

➤ **Your rights and choices**

you have the following rights in respect of your personal information:

- 1) to obtain information about how and on what basis your personal information is processed and to obtain a copy.
- 2) to erase your personal information.
- 3) to rectify inaccurate personal information.
- 4) to restrict processing of your personal information.
- 5) where you have provided your personal information to us with your consent, withdraw your consent at any time.
